#### 3 GENERAL RULES

### **Eligible Entrants and Competitors**

For each car, a crew must be entered consisting of two people, both holders of the Licence required to take part in the event (for the limitations see 2023 RSN and NG). The Licence must be valid.

Holders of Licences issued by ACI Sport and affiliated Federations will be admitted. The following will be admitted

- a) Rally iscritti nel calendario delle gare Nazionali
  - I titolari di Licenza rilasciata da ACI-Sport e Federazioni convenzionate
- b) Rallyes entered in the National Events with Foreign Participants Allowed (ENPEA) calendar
  - Holders of licences issued by ACI-Sport and affiliated Federations
  - Holders of licences issued by an EU country or similar

these Entrants and Competitors are exempt from presentation of the authorisation from their ASN of origin

- c) Rally iscritti nel Calendario Internazionale
  - I titolari di Licenza rilasciata da ACI-Sport e Federazioni convenzionate
  - I titolari di Licenza rilasciata da un Paese UE o assimilato

#### **Eligible Cars**

Cars complying with the Technical Regulations and in possession of the sporting documents required by the current Regulations belonging to the Periods indicated below and in compliance with the provisions of the respective NG and RDS will be admitted.

In the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Group each car must have a valid FIA or ACI Nazionale HTP.

In the 4<sup>th</sup> Group in Classes J1 and J2 all cars must have a valid FIA HTP.

4 PRE-EVENT SCRUTINEERING AND GENERAL OBLIGATIONS VENUE, DATE/S AND TIME/S SPECIFIED IN ART.1 "PROGRAMME"

#### **Administrative Checks**

- a) The Administrative Checks (plates and numbers distribution) will take place according to the official entry list
- b) La corretta compilazione della procedura online di gare e calendari permette di inserire tutte le indicazioni relative al Concorrente/Conduttore permettendone quindi l'inserimento nell'elenco iscritti. To simplify the procedure for the distribution of competition numbers, only the following documents must be presented:
  - Valid driving licence
  - ID Document
  - Medical Certificate
  - FIA or ACI Sport HTP
  - Written Authorization of the A.S.N. should this not belong to the EU, if not sent together with the entry form
  - Receipt of entry fee payment
- c) Competitors who should not produce the documents requested above will not be admitted to the competition
- d) Following Administrative Checks, Competitors will receive all the necessary documents to proceed to Scrutineering, including any bulletins and other instructions issued by Race Control. They will also receive the competition numbers and identification passes

#### 4.1.1 Rally plates and numbers <sup>19</sup>

Each crew will be provided, free of charge, with the competition numbers and the following material:

- A Rally Plate (dim. 43 x 21,5 cm) to be applied on the front of the car
- A transparent adhesive number plate (dim. 28 x 15 cm) to be applied on the rear screen
- Two competition number panels (dim. 50 x 52 cm) to be applied on the doors
- Competition number to be applied on the front windscreen

Cars must be presented at Pre-event Scrutineering with the competition numbers and official plates affixed. The use of adhesive and/or reflecting films on the rear screen, rear side windows and sunroof is authorized, according to the regulations of Art. 253.11/App. J FIA

### **Technical Scrutineering**

- a) At Scrutineering, Competitors must show the ACI Technical Delegate or his assistants the ACI Technical Passport, should this not be part of the HTP.
- b) Cars not in possession of a Technical Passport, FIA or ACI Nazionale HTP will not be admitted to the competition
- c) Any technical dispute will be decided by the Stewards of the Meeting upon notification of the ACI Technical Delegate. If the dispute is of sporting nature, the Clerk of the Course will bring it to the Stewards' attention
- d) Competitors must be present at Scrutineering with the car within the time limits set by these Regulations. Competitors not being present within these limits will not be admitted to the competition
- e) The pre-event Scrutineering will be of a general nature and will mainly concern compliance of the cars to safety standards, the correct classification of the car itself and, where required, the registration

of the tyres, presenting the Registration Form filled in and signed by the 1st Driver and, should they differ, from the same and from the Entrant

- f) Cars not complying with the safety requirements will not be admitted to the start of the Rally
- g) Further technical checks may also be carried out throughout the entire duration of the event

#### **Identification of the Crew**

Each crew member must provide two recent 4x4 cm passport-size photos. During the pre-event checks the photos will be applied to the "Crew

4.1.2 Safety of the Crew

Crews forced to retire must promptly notify Race Control by calling the dedicated and pressing the appropriate button on the Tracking device. telephone number 3791235326

#### Reconnaissance

- a) Reconnaissance must be carried out in the days and times specified in Art. 1 "Programme", after the issuing of the Road Book and the Reconnaissance Card, with strictly standard cars, without any race equipment.
- b) For each Special Stage a maximum number of three passes is allowed
- c) "Relay" cars preceding those in reconnaissance and radio connections in reconnaissance cars are prohibited.
- d) Any reconnaissance carried out outside the established days and times will be considered a very serious infringement and will be reported to the Clerk of the Course for the corresponding measures

### Shakedown, Test with competition cars

### Respect of the Highway Code

Throughout the whole race itinerary open to normal traffic, crews must behave in accordance with the rules of the Highway Code and with all the current traffic regulations, including municipal regulations and any special Urban Police ordinances of the locations along the route.

Crews non complying will face disciplinary measures as per the National Sporting Regulations (RSN)

### Service Area (pa – rsz - ASA), refuelling zones (rz)

During the Rally, servicing to a competing car may be carried out:

- a) Within Service Areas (PA), having characteristics as per the General Rules (NG).
- b) In the designated RSZ areas, having characteristics as per the General Rules (NG).
- c) In those parts of road sections identified as "Authorised service areas" (ASA) by the Organiser, to be pointed out to the Supervisor during the inspection, to be specified in the Regulations, the itinerary and in the Road-book
- d) No service vehicle may drive on the SS route or in any other area identified by the Organisation as prohibited, under pain of a penalty which may be up to the exclusion of the Competitor. Crew members, using only the equipment on board the car and without any external physical assistance, can perform support work on the car at any time, except when expressly prohibited.

In Rallies for Historic cars only it is mandatory to schedule at least one PA for each Leg,

This obligation is not extended in the case of combined rallies for modern historic cars, in the event that the Organiser finds it difficult to source spaces of adequate size and characteristics and capable of satisfying the different needs of the two specialities.

In any case a number of service areas zones (PA-RSZ-ASA) must always be foreseen and adequate for the Assistance and Refuelling needs of historic cars, with distances not exceeding 80 km between them.

- Competitors must strictly comply with the instructions of the Event Officials on duty at the entrance and exit of the PA, RSZ, ASA and RZ.
- The PA, RSZ, ASA and RZ must be clearly shown in the Road Book
- For the entire duration of the Rally, a maximum of two service vehicles will be allowed for each starting car. These vehicles will be clearly identifiable by means of special "Assistenza/Service" plates issued by the

Organiser, which must be applied to the vehicles in a clearly visible position. Other team vehicles (motorhomes, etc.) must be identified by means of "Auxiliary" plates provided by the Organiser

#### Refuelling (NG 14.6)

For all Competitors refuelling is prohibited

Refuelling is only permitted:

- a) Inside petrol stations (only through fuel pumps)
- b) Inside refuelling zones (ZR) suitably set up by the Organiser.
- c) No service work may be carried out inside petrol stations and ZRs. Event officials will check compliance with this interdiction

### Refuelling Zones (ZR) (NG 14.7)

- a) Refuelling Zones must be placed at the exit of the PA and, in any case, in the following two kilometres, in addition to those in other areas of the route (RZ) which the Organiser must foresee according to the limited range of Historic Cars.
- b) The entrance and exit will be shown by a sign with a blue background.
- c) Within the Refuelling Zone, any operation not directly related to refuelling is prohibited.
- d) Within the Refuelling Zone, a speed limit of 5 km/h must be respected.
- e) During refuelling operations, engines must be switched off.
- f) It is recommended that the crew does not remain on board during refuelling operations. Should this not be the case, seat belts must not be fastened and doors must remain open.
- g) In case of failure to start, the car may be pushed out of the refuelling area before carrying out the restarting operations.
- h) The Refuelling Zone must be well delimited. Even barriers alone are enough, but these must ensure complete isolation.
- i) The Organiser must foresee the presence of at least two Officials in the ZR

#### On-event servicing checks (NG 14.8)

In all Rallies, Organisers are required to designate sufficient Judges of Merit to monitor forbidden service/refuelling operations and improper behaviour (e.g. zigzagging to warm up tyres) along the road sections. This personnel will move independently and must be identifiable. When a crew is challenged, they will present their ACI-Sport licence and the credentials of Judges of Merit given to them by the Organiser via the Supplementary Regulations or bulletin. A unit of Judges of Merit must be made up of at least two Event Officials".

#### Parc Fermé

- At the end of each Leg and at the finish of the Rally, cars must be taken to a Parc Fermé set up as per in Art. 1 "Programme" of these SR (26) and parked therein until the start of the next Leg, or until the expiry of the deadline to hand in protests, or the opening of Parc Fermé by the Event Officials, under instructions by the Clerk of the Course following authorisation from the Stewards of the Meeting
- The non- or late presentation of cars into Parc Fermé, or their removal from it without authorization, will result in a sanction which may be up to the exclusion from the classification
- The Parc Fermé, after its opening, will □ will not □ be guarded by the Organiser

### **Protests**

Any protest must be submitted in the ways and within the terms set forth in the RSN

If the protest is of technical nature, a deposit must also be paid for stripping and reassembly costs, the amount of which will be decided without appeal by the Stewards, after hearing th Technical delegates, on the basis of the Tariffs set forth in the RDS.

In the event of a technical protest, the complainant must specify the parts of the car which are subject to the protest and is required to provide all the documentation regarding the protest

For anything not expressly foreseen, please refer to the RSN, the sector-specific RDS and the specific approved Regulations of the respective championships or events

The decisions communicated by posting on the Official Notice Board will be valid as notified in all respects

#### **Appeals**

Any appeal must be submitted in the ways and within the terms set forth in the RNS. The deposit to be paid for each appeal is set out in art. 5.3 App.9 RSN.

#### 8 CLASSIFICATIONS

The following classifications will be established, as foreseen by the NG and RDS in force

- a) Overall, from which will result the winners of:
- Category (1° Cat., 2° Cat., 3° Cat., 4° Cat. separately)

#### 9 PRIZES

#### **Trophies**

- a) Trophies will be awarded, at least 2 per crew, based on the following criteria:
- Rally overall winner
- General Category Classification: to the top 3 classified crews
- Class Classification: to the first classified crew
- Ladies' Classification: to the first classified crew
- Teams (Scuderie) Classification: to the first classified Team (Scuderia)
- b) The prizes for the General Category and Class rankings are not cumulative, therefore only the prize for the most relevant classification will be awarded to the winners of more classifications.
- c) Any prizegiving on the finish ramp will be done with a single podium, consisting of the Drivers or Drivers and cars, winners of the four Categories. The top position will be allocated to the overall Rally winner, the other two podium positions will be allocated indifferently
- d) Based on time and logistics availability, a podium of the first three classified of each Category may be foreseen
- e) The prizewinning Drivers must be present at the Prizegiving Ceremony. Drivers who should not show up at the Prizegiving Ceremony will lose the right to their prizes, without the classifications being changed
